On 02/23/2024 EWUPD was contacted by a reporting party (RP)/complainant (Comp.) who wanted to report a cold sexual assault/rape but wanted to remain anonymous. After speaking with the individual for a short time, he provided his name as **30P** RP **30P** advised he is the parent of **31B** (a Mead High School student).

RP **30P** stated the following in summary: RP **30P** said his son **31B** was a participant at the EWU Football Camp that occurred in the approximate timeframe of June 2023. RP **30P** said his son **31B** told him he was hiding a underclassmen/friend in his dorm room. RP **31B** said it is unknown which dorm **31B** was staying in because he just remembers dropping him off for the EWUFB Camp. RP **30P** said **31B** told him he was helping hide a friend/student who was being hunted down/targeted for hazing purposes by upper classmen. RP **30P** said **31B** told him some highschoolers sexually assaulted at least one student named **31A & 32** RP **30P** advised there may be an additional victim making the total two, but that it is very probable more victims were sexually assaulted.

RP **30P** said he received a call from a Mead School representative on 02/22/2024. RP **30P** said he spoke to them on phone between the approximate hours of 1930 to 2000 hours. RP **30P** said he spoke with Mead High School Principal Kimberly Jensen. RP **30P** said Jensen was crying on the phone, trying to hold it together and advised him he needed to be at Mead H.S. at 0830 hours for a meeting.

RP **30P** said Jensen advised him he was the second parent she had contacted after knowing **31B** was involved with the EWUFB camp incident. RP **30P** said according to his son **31B** one of the incidents occurred in his dorm room during the camp. RP **30P** said his son **31B** told him the suspects (in masks) burst into his dorm room when someone inside the room (unknown who) cracked the door open to see if suspects were still in the hallway. RP **30P** said **31B** told him once the masked suspects came into his dorm room, they grabbed the other male subject (who has only been identified as) **31A & 32** and began sexually assaulting him. RP **30P** said his son **31B** told him he was attempting to hide/shield and protect **31A & 32**

NARRATIVE (continuation)

RP 30P said on 02/23/2024 during the scheduled meeting at 0830 hours, a Mead High School District Administrative Male (said he forgot his name) and Mead Assistant Principal Coretta Hoffman were speaking with him, his ex-wife and son 31B. Per RP 30P he described the discussion they had with his son as more of an investigative interview.

Per RP 30P he said he believes some of the Administration at Mead High School have seen/viewed the aforementioned videos. RP 30P said there are at least two (2) videos circulating of the sexual assault, that he is aware of regarding the sexual assault being filmed. RP 30P said he was advised the Mead School District Title IX Coordinator/Rep (unknown name – possibly could be a Josh Westermann according to the Mead H.S. District website) was/is investigating the allegations/incidents. RP 30P said he felt that he had the responsibility of notifying someone (Law Enforcement) of the incident, outside of the Mead School District. RP 30P said he contacted (crime check) regarding the incident and they re-directed him to contact the corresponding agency where the alleged incident occurred.

Per RP 30P he said it sounded like videos of the incident were being sent around and put out on social media (i.e.) Snap Chat. RP 30P reiterated there should be videos of the incident out there that the Mead School District/Administration has either seen, are aware of and are in currently in possession of.

RP 30P reiterated the sexual assault incident/s occurred approximately in the June 2023 timeframe during the EWU FB camps for youth/high school. RP 30P said as far as he is aware of, only Mead H.S. students (where his son 31B goes to school) are involved but is not positive or certain that no other schools/students could somehow be involved.

RP 30P said his son 31B told him it sounded like the masked suspects were chanting redemption/other chants in the hallway while hunting and targeting victims for the purpose of hazing/sexually assaulting them. RP 30P reiterated his son 31B told him multiple people were wearing masks (possibly upper classmen) who were participating in sexual assault.

RP 30P did not provide any names or identifiers for potential suspects.

RP 30P said it appears his son 31B may have taken a video of the incident while it was occurring to protect himself (so it wouldn't be his word vs. other students words) of what occurred/transpired.

RP 30P said it is unknown for how long (length of time) the Mead School District Administration, his ex-wife (name not provided), or others have been aware of these incident/s or if they ever attempted to make a notification/report the incident/s to any Law Enforcement Agency.

RP 30P advised he would be able to come in to EWUPD on Monday, Feb. 26th, 2024 to speak with

UPDATE:

Josh Westerman promptly relayed the update, informing me that the Mead School District Principal discovered the concerning videos on Tuesday, February 20th. Without delay, they promptly notified the Spokane County Deputy Resource Officer on the same day. The deputy identified and reached out to the two victims and their parents. Meanwhile, Mead initiated their Title IX investigation into the matter. Annika and I are coordinating to schedule a meeting with Josh and the investigating deputy, tentatively planned for Monday or Tuesday. The timing remains flexible as Josh will liaise with the deputy to confirm availability. During the meeting, we will delve into the specifics of the incident, designate leads for both the criminal and Title IX investigations, ensuring seamless coordination between EWU and Mead while minimizing redundancy in communication with the involved parties.

On 02/23/2024 EWUPD was contacted by a reporting party (RP)/complainant (Comp.) who wanted to report a sexual assault/rape anonymously. RP is the parent of **31B** (a Mead High School Student).

RP received a call from Mead School (spoke to on phone at 1930-2000 hrs.) w/ Principal Kimberly Jensen. RP said she was crying on the phone and advised him he needed to be at Mead H.S. at 8:30 a.m. for a meeting. K. Jensen advised him he was the 2nd parent she contacted after knowing his son (**31B**) was involved (incident occ. at his dorm room during EWUFB camp). RP said his son told him they burst into his dorm room (when someone cracked the door to see if they were gone from the hallway) when they grabbed the other male subject he was attempting to shield/protect.

RP said on 02/23/2024, an Unknown Mead H.S. District Admin. Male (forgot his name) and Mead V.P. Coretta Hoffman was speaking with him and his ex-wife. Per RP, he believes some of the Admin. at Mead H.S. have seen videos (2) that he is aware of regarding the incident that was filmed.

RP (Dad of one of the EWUFB Camp. Participants) said his son (**31B**) was hiding underclassmen/younger student in his dorm room (unknown which dorm he was staying in) hiding the student who were being hunted down/targeted for hazing. Per RP, some highschoolers sexually assaulted at least 1 student, possibly 2, but very probable more were sexually assaulted.

Sounds like they were chanting redemption/other chants while sexually assaulting underclassmen. Per RP, he believes there are at least (2) videos the Mead School Dist. has of the sexual assault/rape occurring. Multiple people wearing masks (possibly upper classmen) who were participating in sexual assault.

RP **30P** said the Mead Dist. Title IX Coordinator/Rep (unknown name) was investigating the allegations. RP **30P** said he felt that he had to notify someone of the incident.

EWUPD will be opening a criminal investigation on this reported incident
